2019 Opioid Project Plan Update – other initiatives	<ul style="list-style-type: none"> Narcan Training and Distribution – application will be on the website next week. Any non-profit or government org can apply for up to \$750 for Narcan purchase reimbursement. Approved orgs can apply for reimbursement after the training has occurred. Opioid Awareness and Marketing Campaign RFP – Grant County Health District was selected, Heather Massart is point of contact, will be using a regional coordinator network. School-based Opioid Prevention – Committee has been meeting to come up with a plan to use the funding. Hoping to come up with some ideas from the March 15th conference to help guide in planning. Recovery Initiatives – <i>Deb Miller</i> – Met with recovery coalition, discussed ways that funding could help. <p>Recommendations:</p> <ol style="list-style-type: none"> \$10,000 Training opportunities for people in recovery including train-the-trainer opportunities to increase number of trainings offered locally <ul style="list-style-type: none"> Recovery Coach Training Elevate Recovery Advocacy Trainings \$5,000 Increase awareness and visibility through Recovery Series - Create short professional quality videos of people telling their story of recovery. Will be used to raise awareness, promotion for Recovery Coalitions, and at our Opioid Summit in the fall (if they are done in time) \$5,000 Increase awareness by supporting Recovery Month Events (\$1500 per LHJ) and local Recovery Coalitions (\$500 to North Central Recovery Coalition for recovery bracelets and rack cards) <p>❖ Group endorsed the above plan.</p> <ul style="list-style-type: none"> Rapid Cycle Opioid Awards – revised application - March 3rd- Due April 12th. Making it a 12 month project with midpoint check. Looking for application review volunteers, let Christal know if you would like to be on this committee.

Opioid Data Update	<p>Caroline Tillier gave a Pay for Performance update – See packet for slides.</p> <p>Loretta noted that they can't say that they are a MAT provider because they do not have a prescriber on premise. But they are providing a lot of the counseling and other services that go along with MAT services. They do a lot of referrals back and forth between prescribers and themselves. Colleen Fraser said that they are working on a data base that will identify both types of provider's, meaning prescribers and other services.</p>
Potential Opioid Portal	<ul style="list-style-type: none"> • Caroline gave a demonstration of the WPCC Portal • Discussion of potential Opioid Portal ensued • Julie noted that it is another place to go to look for something. Doesn't see the average person going to this website to get document. Does not think that it would be worth all of the extra work that Christal would put into it. Cathy said it would be nice to have a place to enter things that they are measuring whether it was ACH funded or not. Ryan Poortinga noted that it would be cumbersome to have to log in to a portal. <p>❖ Overall feeling is that portal is not something we want to pursue at this time.</p>
Round Table and Announcements	<ul style="list-style-type: none"> • Opioid Prescribing CME Opportunity – April 15th livestream available (https://uw.cloud-cme.com/default.aspx?P=5&EID=6150) • USDA Rural Action Plan Tackling Opioid Addiction – focus on centralize services in rural locations, school based services, employment with criminal backgrounds and SUD disorders. Christal and Kristi will be leading – putting together a survey with highlights and barriers about people that are in recovery around getting employment. • Drug Overdose Notifiable Condition – Barry sent out an email letting everyone know that they are closed to it becoming public knowledge. Process of getting forms completed by ER went a lot smoother than expected. Only Chelan Douglas is participating at this time. • Jail MAT Programs – Loretta thinks this program in Chelan County is on hold for now. Grant County Jail is doing Naltrexone on a small population of inmates. • Community Partnership for Transition Solutions – Next meeting March 20th in Omak. Meeting quarterly as a region. • Recovery Coalition would like to start a needle exchange in Chelan Douglas. Brock is collecting signatures on a petition. Deb will get a copy of the petition to Christal to send out to the group. The Behavioral Health Advisory Board will decide if they will support after the petition is in. Lisa noted how successful this program has been in Grant County and getting people into treatment on the spot. • Parkside is looking at starting an acute detox in a few weeks. Working on helping patients leave with Narcan. Will need to look at parameters around EMS drop off for detox again. • Colleen Fraser- map of MAT providers is located at www.warecoveryhelpline.org • Rachel From Lake Chelan Hospital EMS – Built a program to provide Narcan trainings. Program has been approved by Dr. Jobe and DOH. They have the next 3 months to provide the trainings and they will provide the agencies with the overdose kits. Added the notifiable overdose into their training.
