# 1. Introductions-

- Deb gives rainbow health bowl demonstration, showing that 20% is clinical care and 80% is the social determinants for the health of the whole person.
- The CHI's job is to work on system improvement from the level of the "whole person", and be the local and ground level voice to determine what changes need to be made for whole person care.

### 4. NCACH Updates -Brooklyn, Sahara

- -As the governing board representative, she can transfer information and ideas to the board. This can insure that we are honoring the voices that are not at the meeting.
- -Demonstration projects are happening, but the HUB has been put on hold. The HUB workgroup conversation will be starting next week. They are in need of Non-Clinical partners. The HUB work group is waiting for an official contract.
