2) <u>North Central Accountable Community of Health (NCACH) Governing Board Updates:</u>-**Brooklyn Holton**

- Pathways HUB RFP- Community Choice was accepted
- The first Pathways HUB meeting was today (June 13th)
- About 108 applications were fully funded around the region for Opioid Rapid Release
- June 30th the NCACH will submit a Semi-Annual Report to HCA
- July 2018 to August 2018 each CHI will be conducting stakeholder surveys
 - The information will help strategize the CHIs regionally wide and at a local level

3) Low Barrier Shelter-Oliver Crain

- Each county is suppose to have a low barrier shelter by the end of June 2018.
- The Chelan-Douglas Landscape Assessment was created by Emily Harris-Shears.
- The shelter will have flexible schedules, ask for minimal documentation and clients are not screened out.
- The ultimate goal is to help lead people on the path to permanent housing.
- This is being adopted throughout the country to help with homelessness.
- Community stakeholders identified this as a priority and provided funding.
 - Stakeholders helped design the layout of the shelter.
 - Interviews and surveys have been conducted with stakeholders.
 - Where are the gaps that are not providing people to be served?
- The planning timeline is from January 2018 to Late June 2018

Rapid Rehousing Program

- Serves households with or without children
- No pre-conditions

Service Plans and Subsides

- Motel Vouchers Emergency Shelter Program
- Only Cascade school district
- Depends on availability

Coordinated Entry

- Landlord debt and evictions are not barriers.
- Only 3 programs conduct drug tests.
- 2 allow participants if sobriety is happening.
- 47% of households find a barrier for permanent housing.
- 33% household serve successful exit to permanent housing.
- No shelters currently can take someone who is in a wheelchair.
- Are you finding any issues with hotel partners?
 - Not right now.

- Can anything be done below Solomon Porch?
 - It is not compliant under the current fire code.
- Is anyone making a plan to update the fire code?
 - The space is too old and cannot be up to the fire code right now.

 - o Core released Performance Measure Dashboard
 - Will be released by county
- All of these metrics are a problem
- What causes the root issues?

 - Reducing the number of medicaid arrests
 - o Discharge from the Emergency Department for Mental Health
