	<p>Develop social marketing campaign measurements (e.g. how individuals access the information, numbers who access information).</p> <p>Recognize the correlation between ACEs and substance abuse. Instill evidence-based trauma-informed policy and practices in youth prevention programs.</p> <p>Consider individual audiences language & cultural differences, age, access barriers, income level, & other social determinants in message development & delivery methods.</p> <p>Utilize available resources to push messages out: School Nurses, School Districts, Parent/Teacher groups, Counselors, etc.</p> <p>Utilize a variety of distribution methods (e.g., social media, radio, newspapers, TV, agency websites, pre-show advertising at regional theatres).</p> <p>Use/expand WIN 211 system content for community & healthcare provider use.</p> <p>Maintain/develop local, state & national communication linkages.</p> <p>Develop sustainable plan for select strategies (funding, content updates, etc.).</p>
